Required COVID Safety Guidelines for Onsite Participants

Office Building Guidelines (as of 6/16/2021)

- Masks are required in all common areas for non-vaccinated individuals
- Hand sanitizers are placed strategically throughout the common areas, including bathrooms, lobby, etc.
- Elevators are limited to four people max; designated corner spots are outlined and there should be no talking
 - ➤ Eating Areas @ Deli lower level
 - Seating in eating areas @ Deli will be allowed during the hours of 11 AM 3 PM Monday –
 Friday.
 - Limit of persons in eating area will be 25 with proper social distancing
 - Face masks are required when not eating/drinking and in all common areas of the building
 - TVs, couch seating, sleep pod, lower level conference room and deli service will not be available
 - Please clean up the area you use wipes will be available

FGIA Office Guidelines (as of 6/16/21)

- Participants can be unmasked while seated in the conference room. Masks are required when you are not seated, or in common areas of the FGIA office. Masks are required in all common areas of the building for non-vacinated individuals.
 - Desks will be spaced at least 6 feet apart
 - Contact <u>education@fgiaonline.org</u> if you are unable to comply with this requirement and would like to request an accommodation
- Complete daily self-reported health questionnaire upon entry
 - See second page for tentative training schedule; plan to arrive 15-20 minutes prior to the scheduled start times to allow enough time for completing the health screen form
- Follow defined one-way traffic flow (e.g., enter via front door, exit via back door)
- Hand sanitizer and disinfecting wipes will be available at each participant's desk; each participant is responsible for sanitizing their area at the end of the day
- FGIA staff will complete sanitization in common areas (e.g., kitchen, door knobs, training room, etc.). Disinfecting wipes will be placed accordingly to facilitate sanitization in between uses.
- Lunch/snacks/beverages will be provided; breakfast will be on your own.
 - o These will be individualized options (e.g., box lunch) to reduce interactions with others in the class
